If anyone is interested in joining the communications team, especially if you enjoy social media, please contact me!

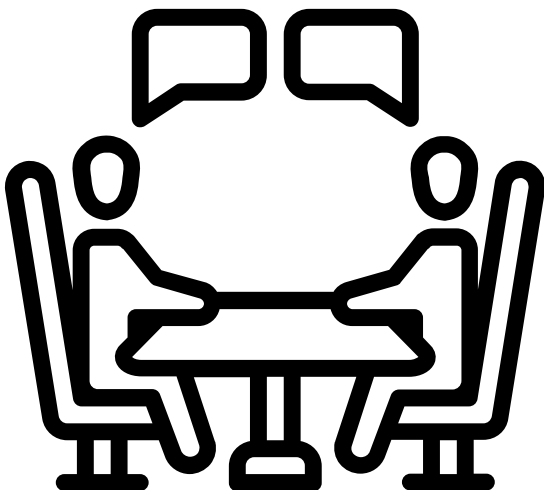
## President's Corner

# CHAPTER UPDATES

## Negotiations

Negotiations for the successor to our contract will begin on June 28-29th. Our Negotiations Team is Labor Rep. Patty Padilla-Salsberg, Ch. 470 President Shawn Pullum, Delia Edeza, Marianna Downie, and Jess Green. We have elected President Pullum as our Chair and we will share the Recorder/Secretary role. Updates from our bargaining sessions will be sent out after we meet.



## Reclassification

After nine months of negotiations with multiple meetings, and waiting for the District to source and review vendors, we signed the reclassification MOU on June 27th. Once VP Beam signs as well, we will begin the ratification process so the Program Support family can begin its reclassification review starting August 31, 2022.

## Safety MOU

We've tried to work with the District since December 2021 to ratify a Safety MOU. We met and came to broad agreement over COVID leave, testing/PPE, and contact tracing. We were all ready to go, but the Board refused to ratify our signed agreement in March/April, and refused to extend it past June 30 on June 21. It just doesn't feel like this Board is prioritizing member safety. The Chapter will continue to advocate for the safety of our members, your families, our students, and the community.

## LEAVES INFO

### SB 114 COVID-19 Leave: Expires Sept 30, 2022

If you have used sick or vacation leave since January 1, 2022 for COVID-related reasons (including vaccination/booster, caring for yourself, or caring for a family member) please submit [this form](#) to get your leave back.

We are entitled to 80 hours of SB 114/SPSL/COVID-19 related leave, ending Sept 30, 2022. 40 hours require proof of a positive test. The other 40 do not. See this [PDF/poster](#) for additional information.

### COVID Vaccination Leave: Expires June 30, 2022

Separate from the above leave, we have vaccination/booster leave still available until June 30 from our prior MOU. If you took time off for vaccine/booster symptoms before the end of this month, you can use this leave as well.



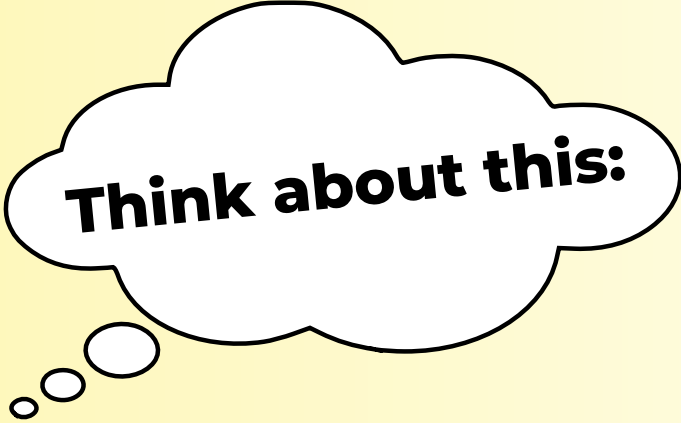
### Vacation Cap Reminder
